# August 8th, 2024 Board of Health & Town Board Minutes

# 129 Daniels Rd #152.-2-5.11

July 11<sup>th</sup>, 2024 the structure on 129 Daniels Rd was to be demolished, was not done so Code Enforcement reached out to the owners again to stipulate that a fence needed to be put around the structure by July 29<sup>th</sup>, 2024. No fence was put up and Code Enforcement tried to reach out to the owners again with no response. Code Enforcement officer Cory Burda ran into Mike Marlett who is not the legal owner or an authorization of agent for the property said a fence would be up by August 16<sup>th</sup>, 2024. The Town Board is willing to give a little flexibility, but if nothing is done by August 16<sup>th</sup>, 2024 the Town Board will start acting on this structure.

#### 4000 Route 9N #125.-1-44

The structure on 4000 Route 9N is in a state of disrepair. The structure on this property is in a state of damage, decayed, dilapidated, structurally unsafe, or of such faulty construction or unstable foundation, that partial or complete collapse is possible.

Deputy Supervisor opened the Floor for Public Comments on any subject. Those that chose to speak were:

Emliy & Cory Westall regarding the safety on Daniels Road. They see many accidents and are hoping that something can be done about the speed before someone winds up getting killed. Kyle Carleton also spoke about the safety and the many accidents on Daniels Road. Deputy Supervisor Capasso said that he will talk to Highway Superintendent Justin Burwell and see if he can move the 2 speed limit signs down around those curves. This is not going to deter people from speeding. Legal Counsel Schachner spoke and said the Town of Greenfield doesn't have the authority to change speed limits or put up signs it must go through the proper protocol which is to the County DOT then the County sends it to the State. The State has the ultimate say and it can take up to 5 years to hear anything. Also, once you apply you can't reapply for that same road another 5 years.
