Snowy Highway Dept. Reminders

So far in 2023, our Highway Crew responded to 35 snow events, making 67 rounds to scrape and salt the roads.

Per our Town Board order, please do not park or leave unattended vehicles, trailers or equipment in the road or within four feet of the pavement during the winter months. Please **do not push snow into or across the street,** as it is against the law. (NYS Vehicle Traffic law Article 1219).

There are many other snow reminders on our website, but please remember to **keep at least 500 feet behind any snowplow**, as they back up often.

Any snow markers should be placed at least two

feet from the edge of the road. Basketball hoops or any other objects must be set back beyond 25 feet from the center of road as well. Garbage cans must be placed in your driveway, not in the road, especially in winter months.

# Thinking about opening a Greenfield business? Get Legit!

Don't be intimidated to work within the local and state business laws when opening a home-based business of any kind. There laws are there to help you and our community. Get legit!

Our Building Dept. is here to make the process easier. Our staff is available to discuss your business idea before you start any work, providing direction to facilitate the process. We will confirm the zoning district your property is in and verify that your business is an allowable use.



Kylee's Kuts, a hair salon on at 196 Bockes Rd. was formed in 2019 on the property of her residence with Planning Board approval.

Most small home businesses require a "Special Use Permit" from the Planning Board (PB). Even if your property previously housed a business, you are required to revise the permit, even if no construction work is being proposed. If construction or renovation is required, stamped blueprints may need to be submitted with the permit application.

The first step is to fill out a PB Application (at Town Hall ) and prepare the necessary plans and materials. Depending on your project, you may need to retain the services of a surveyor or engineer to develop a site plan. Once you've assembled the materials, you may submit the application with the \$100 application fee. If the application is submitted at least10 days prior to the next PB meeting, you are likely to be placed on the next meeting's agenda. The PB meets the second and last Tues. of each month. You or a representative are required to attend. The PB will review your application, discuss the project and ask questions about your plans. Discussion items may include such things as:

- Does the business occur within the house or a separate on-site building?
- Do customers or employees come to the house? How often and where do they park?
- Are you using an existing driveway, and if so, is there adequate sight distance to safely exit to the road?
- Are there any large machines, trucks or cars associated with the business?
- Business hours
- Site drainage, well, septic and trash
- Any noise related to the business

An applicant does return to the next meeting to follow up with additional information, as requested. The PB also will schedule a required Public Hearing. Notices will be sent out to neighbors and they have an opportunity to come to the meeting to support you or ask questions. It typically takes a couple of months to get approved. This is not uncommon in any city or town. The TOG prides ourselves on being community friendly and making the process smooth and quick. If you are reading this and realize you did not set up your small business legitimately, please contact the Building Dept. We are here to help your business set up properly so you can grow and be successful.

It's not about more government oversight, it's about being a good neighbor and protecting the community at large. Following local and state laws when opening your business also protects you from insurance liabilities, violations, and annoyed neighbors. "Legit" businesses join our growing list of those who can proudly promote and market themselves.

### Brookhaven Park Trails Open This Fall

Thanks to the Saratoga County Trails Grant, our Highway Crew added to our trail system through the woods at Brookhaven Park, 333 Alpine Meadows Rd. So far the trail is just under a half mile, featuring three short loops of wide clearing and stone dust surface. Our winter trails are now cleared, so there are many open trails for hiking and walking this late fall and early winter, even before the snow flies.



#### Get to Know Supervisor Veitch

Kevin Veitch was re-elected for another two-year term earlier this month. Born and raised in Saratoga Springs, his childhood home was the now Olde Bryan Inn on Maple Ave. He's held many varied occupations since his start as a young boy separating coat hangers at a Broadway boutique. He worked 11 years at the Saratoga Springs Housing Authority but spent the majority of his career at Saratoga Springs City Hall, where he served as code administrator for 22 years.

He served as a board member and then Executive Director of the Saratoga County Fair, the Gateway House of Peace and Caffé Lena. He currently serves on the First NY Federal Credit Union board. He worked with his two sons, Ryan and Jacob, to create Twin Leaf Farms, a 400-acre maple syrup business in Greenfield.

Veitch moved to Greenfield

25 years ago and spent 16 years on the ZBA Board and 4 years on the Town Board before being elected to Town Supervisor in 2021. When asked how long he has been married to Patti Wilsey Veitch, he quickly quipped "Not long enough." The two have been married for 36 years, own a pug named Jackson and enjoy doting on their two grandkids. He also has been a bass player for 50 years.

Veitch is proud of the Town Board's many accomplishments during his first term, including: expanding emergency services; updating technology and efficiency at Town Hall; restructuring the Building Department; building relationships with state and local leaders; improving Town facilities; and

enchancing communications. Next, he will focus on updating Town codes and hopes to move forward on the planning and building of a new Community Center. Veitch also spends about 10 hours a week on the seven Saratoga County committees of which he is a member.


