October 14th, 2021 Town Board Minutes

The regular meeting of the Greenfield Town Board was opened at 7PM by Supervisor Daniel Pemrick with the Pledge to the Flag. Supervisor Daniel Pemrick welcomed Senator Daphne Jordon and her assistant to the Town of Greenfield. Senator Jordon commended and recognized the Town of Greenfield for becoming a Purple Heart Town. Senator Jordon states the Purple Heart is the oldest, most revered and esteemed Military decoration given out in the name of the President of the United States to those who are wounded or killed in battle for the United States. It is a symbol of heroism and courage and was created by General George Washington to honor and thank the brave soldiers that fought for independence. She has led an effort for towns in the 43rd Senate Dist. to become Purple Heart Communities to honor those who have given all. Senator Jordon presented the Town of Greenfield with a Senate Proclamation honoring the Greenfield's recognition becoming a Purple Heart Community.

EMS COMMITTEE REPORT- Capasso, C states the lease for the building is almost complete. The landlord will be responsible for the heat and electric and we would be responsible for the rent. Mr. Cornell would like section 8 taken out of the agreement. He is looking for a commitment letter from the Town. Town Counsel states he has not been a part of any provisions of this lease. What is in there is what he was told to put in. Town Counsel also states the lease is the commitment. He also received an email sent to the Board members, (excluding Johnson, C). Counsel reads the email stating that Mr. Cornell is not happy with section 8, there should be no separate electric needed, there may or may not be separate heating needed. In prior discussion on this project he made it known that the building was heated with one heat source and did not included the garage. We must still be able to heat the living spaces with the current heat source, this is to be determined either way if another heat source or electrical heater is installed. This will be the cost of the tenant and not the land lord. Johnson, C states she is not in favor of that. If it is going to be the cost of the tenant now, we are paying \$30,000 for the lease agreement, and that \$30,000 is going to include the electric and heat why are going to pay for heat again. We would be paying for heat twice. It is already included in the \$30,000 plus we are paying extra. That's why she asked before if any of this becomes our responsibility as tenant then there has to be a reduction of the \$30,000 or you are paying for heat twice. Part is the \$30,000 and part as a bill. Veitch, C says the building inspector will have some say. The large area where the ambulance is going the heating system in place may not be able to maintain the heat that is needed, so a second smaller source may be

needed. Capasso, C states that Mike Waldron said with the build out, walls etc, it may require 2 separate heating systems. He says that if he puts a heating system in then the rent would need to go down. That's not going to be required. The heating system will be one heating system. Johnson, C says that is not what was just read. That's why she is confused. The email says if a second heating system is put in it's the tenants' responsibility. That goes back to where we were, we would be paying twice, once in the rent and then for the extra source. Supervisor Pemrick states that Mr. Cornell's attorney suggested that everyone sit down and talk it out. Capasso, C states the need to get this done and if we can't look for another building.

<u>COMMUNITY CENTER COMMITTEE-</u> Stacey, C states that they will meet again in a month. They are just brain storming and reaching out to get ideas.

Monthly reports were submitted by the Town Clerk, Highway Dept., Town Justices and Building Dept.

DISCUSSION BROOKHAVEN PARK- Recreation Director, Rebecca Sewell, states she wrote a grant and won it through Game Time. The Town would need to match the grant. There are two companies that would like to provide the playground equipment, Game Time and Kopman. She discusses the differences between the two companies equipment. She feels the Town is getting a \$160,000 - \$200,000 playground for \$130,000 installed. Veitch, C asks about wheelchair accessibility. Rebecca states that all playgrounds are ADA compliant. Town Counsel states he did not hear where we went through a competitive bidding process. We are thousands of dollars over the competitive bidding thresh hold. Rebecca states the bidding process is two vendors. Johnson, C states those are quotes. It would be a sealed bid. There no hurry to rush into this and asks what she means when she got a grant through Game Time? Mrs. Sewell states that Game time offered a grant process where she had to tell why our Town would be a good place to give money to. Three towns won, Albany, Ballston Lake and Greenfield. Counsel Schachner state his concern is there may be another vendor who did not get a chance to bid. Under State Law you need to put it out to bid formally.
