COREY & KIMBERLY BARSS – Special Use Permit

Corey and Kimberly Barss are present. T. Yasenchak opens a public hearing at 7:02 p.m. C. Barss explains that they would like to move their mobile home from its current location in Ballston Spa to this lot on Allen Road. There being no public comments, this public hearing is closed at 7:03 p.m.

T. Yasenchak explains that the applicants also have an application before the ZBA at their July 5, 2011 meeting so any approval tonight would be contingent upon the ZBA approval. S. Weeks asks why this application requires a special use permit. T. Yasenchak explains that it is because of the way the Town Code is currently written and that we are waiting for a revision of this requirement from the Town Board. C. Baker states that he has no engineering issues and that the applicants will be required to file a site plan with G. McKenna for their building permit. SEQRA is discussed and not required.
