<u>Transmission Line Determination for Upper Plank Road</u> – Supervisor Rowland advised that the Town Board had received a memo from Sean Crotty concerning an issue regarding the Town's code requirements pertaining to utilities for subdivisions. Mr. Crotty explained that he owned a piece of property up on the end of Plank Road which they are in the process putting a small passive solar home on. He is having issues with National Grid. He believes that National Grid feels that they have received different answers from the Highway Supt. and Code Enforcement Officer. Mr. Crotty explained that there were a couple of different issues. One involved the

Subdivision Code where it requires any new electric for a subdivision to be put underground. Mr. Crotty's property is at 374 Plank Road and is not part of the subdivision. Mr. Crotty explained the plan presented to the Board which indicated where the utility easements were, where the primary line was located, the new distribution line, etc. He was asking that this 2010 be approved so that National Grid is not confused as to what can or cannot be done. He believed that National Grid would like to bring a new primary line up Plank Road from Ridge Road overhead. He noted that there is already a primary line in the area. The Code Enforcement Officer has told them that they have to go underground because it is a subdivision. Then they are calling the Highway Supt. hoping that he will say that they can go overhead for the whole way. What they would like to do is go back to that original plan and have everything go overhead up to Mr. Evans' property and from that point on be underground. Pemrick, C. questioned why this was in front of the Board and not before the Code Enforcement Officer. Mr. Crotty stated that National Grid made 2 phone calls and received 2 answers and they are not willing to move forward without a consensus of the Town. Kinsella, C. felt that up to the point 230 the power could go overhead since it would be located along an existing public road. It would from that point on that would have to go underground. Highway Supt Barss stated that it was his understanding that National Grid wanted to move the power line out of the woods to the road. It was their feeling that they would have to run the power underground all the way from the last pole on Plank near Ridge Road which they can not do due to the fact that there is already infrastructure in place under the road. Kinsella, C. felt that since the pre-existing line was already above ground they would be able to move the main infrastructure and have it remain above ground. Dave Evans stated that the Town Code was not very clear as to whether underground utilities were required for just new subdivisions. Kinsella, C. stated that the paragraph regarding utilities was in the section of the Code that pertained to Subdivisions. Mr. Evans stated that is his case he has a mile and a half of line and the Town is asking him to put it underground. Pemrick, C. felt that this matter should be decided by the Code Enforcement Officer and advised the applicant to go back to Mr. McKenna.
