Supervisor Rowland stated that he has expressed his desire to Town Counsel to get the process moving along since we are already at the first of the year. There is a lot that needs to be done once the Town owns the property in order to be ready for the upcoming season. The Board needs to be able to sign agreements with the food service operation, employees, put together a budget, etc. Chandler, C. questioned if the Board would be working closely with the current staff and whether funds would be set aside to make sure the greens, etc. were ready for the season. Supervisor Rowland stated that there are deposits that are coming in for season play for next year which we should be able to use as some of the start up money that will be needed. Kinsella, C. stated that there had been discussions regarding putting together a team/committee that would start looking at the different options/uses for the park and questioned when that was going to take place. Supervisor Rowland felt that the Board needed to get going on that soon. He was just waiting for the transfer of ownership to take place. Kinsella, C. stated that he felt uncomfortable piecemealing the process with individual resolutions without seeing the whole plan and having a better understanding of the objective. Pemrick, C. felt that this year was going to be a learning year. We may have to get through a season before we really begin to figure out where we want to go with this. We need to talk about parkland also and not just the golf course.
