PUBLIC COMMENTS - Jay Ellsworth, Greenfield Fire District Chief states he understands the Town is negotiating with Wilton and Saratoga for Wilton's coverage of the Town. He is not sure that the Town knows the Fire District buys into the CME program for \$7000. which is continued education for the EMTs. When their card comes due, they can get the classes they need. He is not here to side with anyone. He feels the Board needs to understand if the Board goes with Saratoga, Wilton will not provide the services to the Fire Dept. The Fire District has to have a medical director which they have been using Wilton's. They will need to look for a new medical director. He is sure the switch is over costs and he understands that. Chief Ellsworth states the Board is looking for a January 1st turnover date. There's more to it than switching providers. He is Chief of the Fire District and no one has called him to ask his opinion. A switch affects the Fire Dept. If they do not have a medical director, then the EMS program is on hold. There will be a new Chief next year so there needs to be one in place by the end of the year. In speaking with Chief Dolan from Saratoga, they use Empire for mutual aid. Empire does not have a good reputation in this Town. Supervisor Pemrick, states that he received an e-mail from Nash Alexander from Wilton that states the items you have mentioned. Supervisor Pemrick states he was not aware of all of them. He did not call the Fire Chief because in his mind it was separate. He did call the County and spoke with Mr. McAvoy who is in charge of EMS services within the County and indicated that we are considering a change in services and seeking bids form all the parties involved. He asked to be made aware of any unintended consequences in making this move. He received no concerns from them. They may have assumed we knew all these details. We weren't so naïve to think there weren't details behind this. Matt Fogarty from Jessup's Landing has offered to help with any paperwork. As Chief Ellsworth pointed out it is getting expensive. The Town does have its own Municipal Certificate of Need. These are annual contracts and that is the way we would like to keep it. He feels all involved can work together to have things in place by January 1. Speaking for himself we don't favor one over the other, we need to save as much money as we can. He feels the Saratoga would not be using Empire Ambulance if they were not competent. Capasso, C. asks Chief Ellsworth what was the problem with Empire. Chief Ellsworth states that Empire was to have one EMT and one Paramedic. That was not the case. They had EMTS, but no paramedics. He started asking who is the paramedic on board, they did not have one. The Town paid them to have that. If it was a bad accident they were not able to come here because they did not have the proper people on board. As Chief of the District he hopes they have gotten better. Supervisor Pemrick states he thought there was a number of mutual aid ambulances. Chief Ellsworth states if Wilton is called and they come out of Moreau or Schuylerville he will cancel them. He is not going to wait for them to come from those areas if someone is sick and needs help. Supervisor Pemrick states we have contracted with Saratoga and Chief Dolan is looking forward to working with us for the next year. The Fire District has been good to let the Town participate in the State required Sexual Harassment and Workplace violence classes. If the Town needs to help with the cost of that service the Town may be willing to help with a portion of that cost.
