

October 17th, 2018

A Special Meeting of the Town Board was held on Thursday October 17th, 2018 at 7:56 PM with the following members present: Daniel Pemrick, Supervisor; Daniel Cochran, MaryAnn Johnson, Rick Capasso and Kevin Veitch, Councilpersons. Also present were Walter Barss, Superintendent of Highways, Deputy Highway Superintendent of Highways, Duane Wright and Joan Stunzi, Budget Officer.

Walt Barss states that the Dog Control Officer's truck is in disrepair. The frame under the bed is completely rotted and unrepairable. It is not safe to pick up animals or for the Dog Control Officer. He recommends taking the Ford escape that is used for the Building Inspector and using that for Dog Control. There's a 2019 Chevy Silverado on State Contract for \$29,000. That is a great price for anything these days and it is important to be safe.

RESOLUTION #134- PURCHASE TRUCK FOR BUILDING INSPECTOR

On a motion by Capasso, C. and seconded by Cochran, C. the meeting was adjourned at 8:48 PM.

October 24th, 2018

A regular meeting was opened on October 24th, 2018 at 6:17 PM with the following members present: Daniel Pemrick, Supervisor; Daniel Cochran, MaryAnn Johnson and Kevin Veitch , Councilpersons. Absent was Rick Capasso, Councilman. Also present were Walter Barss, Superintendent of Highways; Duane Wright, Deputy Superintendent of Highways; Joan Stunzi, Budget Officer and 4 residents.

Discussion takes place on the increased cost of Wilton Ambulance service. Supervisor Pemrick states they wanted to add \$17,000 to their yearly amount, but they have negotiated and it will go up \$8,000. Also, the Recreation Dept. asked for an increase of \$25,000 in order to add to the summer camp activities and purchase new playground equipment for Middle Grove Park. The Town is going to decrease that amount to \$16,000.

October 24th, 2018

PAUL BOUCHARD – Asks the Town to keep in mind that if Prestwick Chase goes through with their plans to increase then there will be more calls and possibly an added increase in cost to the Town.

JAMES VAN DYK- Questioned how billing is done. The Town has to pay ambulance service and the patient gets billed also. Supervisor Pemrick states that the comments are something that the Town has to look at and see what options we have.

NOTICE is hereby given that the Preliminary Budget of the Town of Greenfield for the fiscal year beginning January 1st, 2019 has been completed and filed in the office of the Town Clerk, Town Hall, Greenfield Center, NY where it is available for inspection by any interested person at all reasonable hours.

FURTHER NOTICE is hereby given that the Town Board of the Town of Greenfield will meet and review said preliminary budget and hold a public hearing thereon, at the Town Hall, Greenfield Center, NY at 7:00 PM on the 8th day of November, 2018, and that at that hearing any person may be heard in favor of or against the preliminary budget as compiled, or for or against any item or items as therein contained.

Pursuant to Section 113 of the Town Law, the proposed salaries of the following Town officers are hereby specified as follows: Supervisor - \$21,759; Councilman (4) each \$8,557; Town Clerk - \$55,001; Town Justices - \$17,184.; and Highway Superintendent - \$73,181.
