

October 24<sup>th</sup>, 2019 Town Board Minutes

A regular meeting of the Town Board was opened at 6:30 PM with the following members present: Daniel Pemrick, Supervisor; Rick Capasso and Kevin Veitch, Councilpersons; absent were Daniel Cochran and MaryAnn Johnson Councilpersons. Also present were Walter Barss, Superintendent of Highways; Duane Wright, Deputy Superintendent of Highways; Joan Stunzi, Budget Officer and approx. 4 residents.

Supervisor Pemrick states that we have our tentative budget that we need to accept for 2020. We have discussed tonight a reduction in the highway fund of \$50,000. We have not heard from all of our EMS providers, but we know there will be an increase in the cost of this service. We have updated our parks and playground equipment. Some repairs and possible replacement of equipment may be necessary.

NOTICE is hereby given that the Preliminary Budget of the Town of Greenfield for the Fiscal year beginning January 1<sup>st</sup>, 2020 has been completed and filed in the office of the Town Clerk, Town Hall, Greenfield Center, NY where it is available for inspection by any interested person at all reasonable hours.

FURTHER NOTICE is hereby given that the Town Board of the Town of Greenfield will meet and hold a public hearing thereon, at the Town Hall, Greenfield Center, NY at 7 PM on the 7<sup>th</sup> day of November, 2019 and at that hearing any person may be heard in favor of or against the Preliminary budget as compiled, or for or against any item or items as therein contained.

Pursuant to Section 113 of the Town Law, the proposed salaries of the following Town Officers are hereby specified as follows: Supervisor - \$22,303; Councilpersons (4) each - \$8,771; Town Clerk - \$58,426; Town Justices (2) each - \$17,614 and Superintendent of Highways - \$70,000.
