A Special Meeting of the Town Board was held on October 20th, 2010 at 6:45 PM with the following members present: Richard Rowland, Supervisor; Daniel Pemrick, Thomas Kinsella, Daniel Cochran and Walter E. Chandler, Councilman. Also present was Highway Supt. Walter Barss, Budget Officer/Bookkeeper Joan Kelly and 4 residents.

Joan Kelly advised that following the last workshop she adjusted the budget to include a 3 ½% salary increase for everyone as discussed, including the Board, since no decision had been made regarding their salaries. The Board has not received a raise for the past 2 years. The proposed increase to the Board would make a difference of \$1,900. Chandler, C. was opposed to a raise. The Board is taking money out of reserves for this budget and did not feel that the Board should have a raise. Cochran, C. stated that originally he as not in favor of a raise either. Since the Board has not had a raise in 2 years, he would not be opposed to the 2% raise that was originally proposed. Kinsella, C. agreed with a 2% increase.
