

## **April 11<sup>th</sup>, 2024 Town Board Minutes**

The regular meeting of the Greenfield Town Board was held April 11<sup>th</sup>, 2024 at 7 PM with the following members present: Kevin Veitch, Supervisor; Mike Gyarmathy, MaryAnn Johnson, Ty Stacey, Rick Capasso Councilpersons. Also present was Town Counsel Mark Schachner and 7 residents. The Supervisor opened the meeting with the Pledge to the Flag.

On a motion by Capasso, C and seconded by Gyarmathy, C the minutes from March 14<sup>th</sup>, 2024 were approved as submitted by all members present.

On a motion by Stacey, C and seconded by Capasso, C the Town Board moved to Board of Health at 7:05 PM to discuss the report of an unsafe building that was submitted by the Code enforcement Officer. The house at 129 Daniels Road was found to be structurally unsound and has the potential for collapse. The structure has been deemed unsafe as the structure is currently being supported solely by what appears to be 4X4 lumber. On a motion by Capasso, C and seconded by Johnson, C the Town Clerk was directed to send a Notice of Unsafe Building to the property owners and that a hearing be scheduled for 7:00 PM on May 2<sup>nd</sup>, 2024.

On a motion by Johnson, C and seconded by Stacey, C the Town Board convened to their regular meeting at 7:10 PM.

The Town of Greenfield Historical Society would like permission to use the Caboose, King's Station, and King's Station Park, located on the corner of Route 9N and Potter Road for us to host the 13th Annual Caboose Day. Caboose Day is scheduled for Saturday, August 10, 2024.

For safety reasons, we have moved the Car Show to our July Event in Middle Grove.

Please note:

- The Town in the past has paid for the "Paid Box Advertisement" in *Saratoga Today*.
- The Town in the past has provided a "Porta-Potty (handicap type)" and one regular. With the crowd we have had in the last couple years, we would like to request three (3) Porta-Potties total this year.
- We would like 8 picnic tables available at the location to provide an eating area as we have done in years past.
- We would like the Town to double check the grounds for holes and unwanted brush for the safety of attendees.

This year, we expect the Saratoga, Corinth and Hudson Train to run a special schedule, dropping off and picking up passengers two times during the event. Plus, they will run a shorter train ride from this location south, on the hour. The train was a big attraction last year and we expect it to be again this year.

For safety reasons, we have asked the Fire Police to be stationed at both the entry of the parking area and at the bend of Porter Road where the passengers access the road to get to the King's Station Park.

We have also hired a Trolley from Upstate Transit of Saratoga, LLC to transport passengers to and from the train at King's Station, providing a fun and safe way to get from the train to the site and help for those with accessibility issues. This is a very costly item for us; therefore, we have asked for donations to help defer this cost. We wish there was a closer location for the train to stop and drop off/pick up people.
