A special meeting of the Greenfield Town Board was held July 3rd, 2024 at 7:00 PM at the Greenfield Town Hall with the following members present: Kevin Veitch, Supervisor; Mike Gyarmathy, MaryAnn Johnson, Rick Capasso and Ty Stacey Councilpersons. Also 2 residents were present.

On a motion by Gyarmathy, C and seconded by Stacey, C the Public Hearing for Partnering with Rebuilding Together Saratoga County opened at 7:02 pm. **Motion Carried**

Michelle Larkin Executive Director of Rebuilding Together Saratoga County was here to speak about what they actually do. Rebuilding Together Saratoga County is a nonprofit organization founded in 2003. They provide critical repairs and accessibility modifications for low-income homeowners in Saratoga, Warren, and Washington Counties, at no cost to the people they help. The team includes 6 full-time staff, 5 part-time staff, a part-time Accountant (contractor), and a part-time Grant Writer (Contractor). Michelle stated that Rebuilding Together currently has 17 homeowners on a waiting list in Greenfield. This funding will allow them to prioritize these applicants, who other wise will have to remain on a waiting list until additional resources can be secured. Supervisor Veitch asked if anyone had any questions for Michelle. No questions were asked. Supervisor Veitch closed the Public Hearing at 7:20 pm.
