

June 6th, 2024 Board of Health & Town Board Minutes

The Town Board met as a Board of Health on June 6th, 2024 with the following members present: Kevin Veitch, Supervisor; MaryAnn Johnson, Rick Capasso, Mike Gyarmathy and Ty Stacey Councilpersons. Code Enforcement Officer Justin Reckner was also present along with 5 residents.

On a motion by Capasso, C and seconded by Stacey, C the Board of Health hearing was opened at 7:00 pm for the unsafe building at 430 Locust Grove Road, Tax Map #138.-2-53.1. The building is in a state of disrepair. The dwelling was deemed unfit for human occupancy under the provision of NY107.1.3 of the 2020 Property Maintenance Code.

Tammy Salvi owner of the property was here along with Kelly Hurley her friend trying to help her out. Supervisor Veitch asked Ms. Salvi what her intentions are with the building. Ms. Salvi said she would like to demolish the building. Code Enforcement Officer Justin Reckner said that the building really needs to come down and then the process to rebuild can begin if that is what her intentions are to do. It was determined that 430 Locust Grove Road will be demolished freely by the property owner. A demolition permit will need to be obtain by July 8th. If no action is taken to bring the property into compliance the Town will remove the structure and all costs incurred by the Town will be charged to the Town and County tax bill.

On a motion from Stacey, C and seconded by Capasso, C the Board of Health meeting was adjourned at 7:12 pm.
