Tonya Yasenchak chair for the Greenfield Planning Board is here to discuss with the Town Board simplifying Planning & Zoning Board Processes. Tonya talked about Public Hearing Site Signage, Public Hearing Neighbor Notifications, Public Hearing Ad fees and Engineering review escrow fees. They would like to retain Adirondack signs to fabricate public hearing notice signs for public hearings. The sign would be the size of a standard real estate sign printed on both sides. The cost would be \$37.50 per sign. Tonya also suggested that notifications and public hearing ad fees would be the responsibility of the applicant. Tonya also stated that they would like to reduce the open space fee (escrow) for minor subdivisions only. The Board thinks these are really great ideas and fully support the changes that the Planning & Zoning Boards would like to make. When they get the full changes done they will bring it before the board again for approval.

Stephanie Ferradino is here representing Twin Leaf Farms LLC. Supervisor Kevin Veitch and Councilman Mike Gyarmathy have recused themselves from this discussion. Twin Leaf Farms is seeking a short-term generic Mass Gathering Permit to host events at the Barn while the PUD application process is pending. The Barn would like to host one event per month. The code for Mass Gatherings is very specific to certain items. Days, Activities and Site are specific items for a mass gathering permit. Town Counsel Mark Schachner states that the code does not allow for Generic Mass Gathering Permits. The purpose is to allow the Town Board to know what exactly is purposed on what specific day, by what organization and where, not a generic on what could happen but what is going to happen. If it is an event that the Town Board is not happy having in the Town of Greenfield you are obligated to go through with it because you have issued a Generic Mass Gathering Permit. The time frame is what holds up the applicant. You have to have it in 60 days before the event. The 60 day can be changed but then you would have to have a local law and public hearing. Stephanie will propose a draft to Mark in regards to the time frame, to review and then it will come before the Town Board and then they will decide then what will be done or what needs to be done. Until then each applicant will have to submit a Mass Gathering Application for each event.
