SENIOR TAX EXEMPTIONS

Real Property Tax Exemptions for Senior Citizens - At least one owner must be 65 years of age. The property must be the primary residence of the owner.

Income Levels – Total income of owner(s) can not exceed the following amounts in order to be eligible:

- Saratoga School District - \$37,400
- Corinth School District - \$30,700
- Town - \$29,700
- County - \$35,700
